
Subject: Grant of NOC for setting up school at vill. Kurali Distt. Karnal.

Reference: Your application dated 08-08-07 & 17-10-07.

On the above cited subject, your application for grant of No Objection Certificate for setting up a school over an area measuring 19 Kanal 7 Mailla comprising Khasra Nos. 27//1/1, 2/1 28//5/2/1 in the revenue estate of vill. Kurali District Karnal has been examined in this office. In the light of report sent by DTP Karnal vide memo no. 3762 dated 05-09-07 & legal advice received from D.A., H.Q. DTP has intimated that the site mentioned above does not fall within any controlled area declared by this Deptt. under Act no. 41 of 1963, but falls within urban area Karnal. Therefore, it has been decided to grant NOC for setting up a middle School over the above said land subject to the following conditions.

1. That you shall obtain the necessary permission from the any other department required for the said project under any other act.
2. This certificate does not provide any immunity against any Act, Rules and Regulations of any other department applicable at the land in question.
3. This NOC shall be considered null and void as soon as the controlled area will be declared at the site in question.
4. That you shall not raise any construction within ROW of Electric line passing through the site.
5. That you shall not raise any construction within 30 mtr. restricted belt along Karnal-Indri scheduled road.
6. That you shall adopt the planning norms as per NBC during actual execution^{building} at site & you shall be sole responsible for structural safety as well as provisions made for fire safety in said building.


Any breach of above said conditions will tantamount automatic cancellation of this NOC.
